County Unemployment Rate Seasonally Adjusts to 6.5% in January

There was good news and bad in the Santa Barbara County employment figures for the month of January 2015 that was released today by the State Employment Development Department (EDD). Although January’s 6.5% unemployment rate (14,100 unemployed out of a labor force of 217,100) is an increase from the December 2014 rate of 5.7%, all of the county’s cities reported single-digit unemployment, with Lompoc dropping down to 8.5% from December’s 10.2%

Between January 2014 and January 2015, the County’s labor force grew a healthy 1.7% from 213,500 to 217,100 or 3,600 workers.

“Most of the increase in the unemployment rate since December,” said Santa Barbara County Workforce Investment Board Executive Director, Raymond L. McDonald, “is the result of adjustments from the Holiday and End-of-Year activities.”

“The sector reporting the largest job loss was Local Government,” explained McDonald. “This is consistent with schools being out for the holiday recess and semesters ending. Of the 1,400 jobs lost in the Government sector, 1,100 were from education. This is seasonally driven job loss. What’s more important is the 3,600 workers returning to the job market because the want ads and recruitments have encouraged them that they can find a job.”

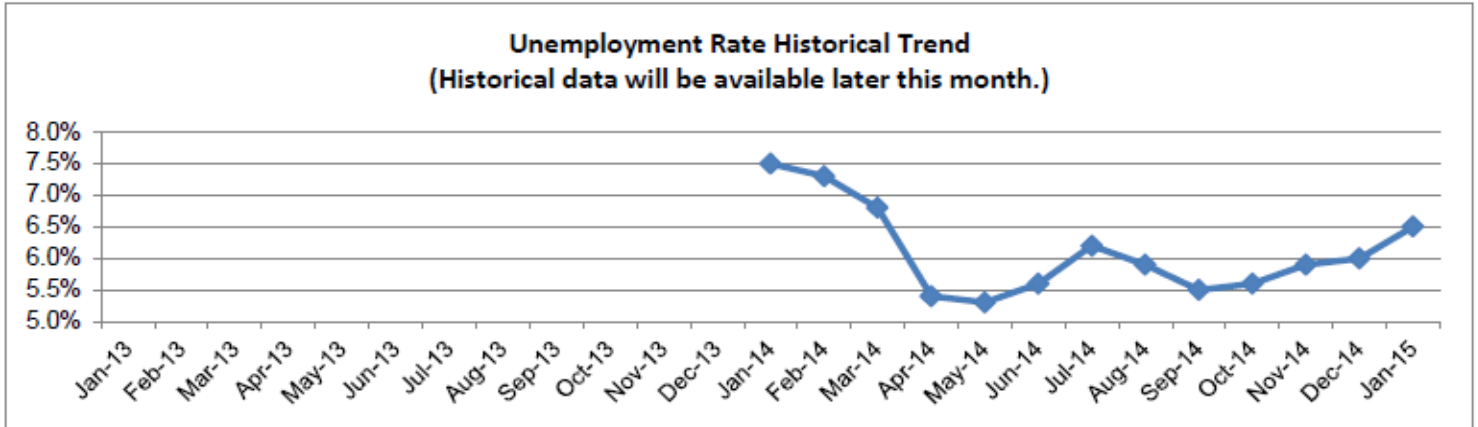
Beyond the Government job losses, the other sector hit hard in January was the Retail Sector with clothing stores losing 200 jobs and food & beverage stores decreasing by 100 jobs. These, too, can be seen as reflective of the end of the Holiday Season shopping and companies employee parties, dinners & lunches.

Returning to the sub-county areas, Goleta posted the lowest city unemployment rate of 3.9%, while Lompoc’s 1,500 unemployed resulted in the aforementioned 8.5% rate. Still the largest number of workers unemployed was in Santa Maria, where 3,800 of its residents were unsuccessful in finding work. Santa Barbara residents, with 2,700 unemployed, did a little better than Santa Maria, with a 5.2% unemployment rate.
